Questions and Answers

The following questions were sent to E&I by Friday June 28, 2019.

1. In Part 2, Section 2.4 "Pricing" on pages 8 & 9 – Does the List Price file need to be submitted with the RFP response or upon award?

Answer 1: The List Price file shall be submitted with the RFP response in electronic, Microsoft Excel, format.

2. In Part 2, section 2.13, "Delivery" on page 12, third paragraph; please clarify the first sentence that reads "A member may request overnight delivery of products not normally stocked by the Supplier through their distribution center overnight at no additional charge."

Answer 2: This sentence refers to items that are drop shipped. Items not stocked by the Supplier need to be shipped via Overnight delivery at no additional charge.

3. In Attachment A1, Tab B, Category Price List, clarify the instructions

Answer 3: Instruction number 2, says "Column C - Provide the proposed discount for each available category." This is the instructions for Column D.

Instruction number 3 says "Column D must contain the price list number for the current list price being proposed." This is the instruction for Column E.

Instruction number 4 says "Column E - provide any notes per category that will help the evaluation Team understand your price proposal by category." This is the instruction for Column F.

Addition to the Scope of Services, Section 2.4 - "Central Receiving & Last Mile Distribution Fee"

Central Receiving & Last Mile Distribution Fee

Members may operate a Central Receiving warehouse that will be used for most campus deliveries providing Supplier with the ability to ship in palletized, bulk deliveries. While the catalog pricing submitted in this RFP should be the same for direct or palletized shipments, the members with Central Receiving will charge a fee to the Supplier for all centralized shipments in the form of a "Last Mile Distribution Fee" (the Fee). For members with Central Receiving, the Supplier shall pay the Fee, in an amount negotiated between the Supplier and the member based on the gross funds received by the Supplier from that specific member. This fee will apply to any and all products sold by the Supplier that are delivered to that member's Central Receiving location.

The Fee, by member, will be calculated and reported quarterly based on all sales transacted. The Supplier will submit the Fee, along with quarterly reports documenting all sales, to the member within 30 days following the end of each calendar quarter. Each quarterly report shall include as a minimum, all purchased goods, price paid, and quantity, by individual purchasing agency, for all sales within the prior calendar quarter.

These changes constitute an addendum to the above referenced RFP and are made a part thereof.
