The items below were identified as sections of the RFP that needed to be updated. The following changes are hereby amended into this RFP.

1. On page 8 in Part 2, section 2.4, "Pricing", Letter A, Market Basket Items shall be deleted in its entirety and replaced with the following;

Market Basket Items (Tab A)

Tab A of Attachment A1 contains a collective list of 300 high spend/volume items purchased by a sample of the E&I Membership. Please provide a price proposal for all items listed. **If Suppliers have the exact match of an item in its catalog, it must be included in the submission.** If Suppliers do not carry an exact match of a product, a technical equivalent may be entered in the space provided (Column J). Suppliers **must** propose at least 80% of the 300 items listed. E&I, in its sole discretion, may deem a Supplier's proposal as non-responsive if the Supplier fails to meet the 80% threshold.

2. On page 9 in Part 2, section 2.4, "Pricing", the last sentence of this section, in reference to "**Restocking Fee**" shall be removed.
3. On page 16 in Part 5, section 5.2, Tab 6, remove "Attachment I – Exception Form". The Exceptions form shall remain under Tab 3.
4. On page 21, Attachment A, item #2 shall be deleted in its entirety and replaced with the following;

Price Adjustments

List price increases, not to exceed 2%, are allowed once per year. List price increases require a minimum 90-day advance written notice by Supplier and approval from E&I prior to implementation. The new proposed price list must accompany the 90-day written notice from the supplier. List price decreases are allowed at any time during the term of the Agreement. Supplier shall provide E&I written notice immediately of all list price decreases.

These changes constitute an addendum to the above referenced RFP and are made a part thereof.
